**JUDGMENT**

This cause came to a jury trial on February 18, 2014. Plaintiff Eric Sanders appeared by his attorneys Lynne Jaben Bratcher and Kristi Kingston. Defendant City of Kansas City, Missouri appeared by its attorneys Tara M. Kelly and Nikola Smith.

A jury was seated on February 18, 2014 and evidence was presented through February 26, 2014. At the close of Plaintiff's evidence, Defendant made a Motion for Directed Verdict. The motion was DENIED. At the close of all evidence, the Defendant renewed its Motion for Directed Verdict. The motion was DENIED. Following closing arguments by each party (which occurred on February 26, 2014), the jury recessed for deliberations.

On February 26, 2014, the jury returned its verdicts as follows:

On the claim of Plaintiff Eric Sanders for racial harassment against Defendant City of Kansas City, Missouri, the jury found for Defendant City of Kansas City, Missouri.

On the claim of Plaintiff Eric Sanders for race discrimination against Defendant City of Kansas City, Missouri, the jury found for Defendant City of Kansas City, Missouri.

On the claim of Plaintiff Eric Sanders for retaliation against Defendant City of Kansas City, Missouri, the jury found for Plaintiff Eric Sanders, and assessed damages in the amount of ninety thousand dollars (\$90,000.00).


IT IS THEREFORE ORDERED, ADJUGDED AND DECREED that per the verdict referenced above, on the claim of race discrimination against the Defendant City of Kansas City, Missouri, judgment is entered in favor of Defendant.

IT IS FURTHER ORDERED, ADJUGDED AND DECREED that per the verdict referenced above, on the claim of racial harassment for racial harassment against Defendant City of Kansas City, Missouri, judgment is entered in favor of Defendant.

IT IS FURTHER ORDERED, ADJUGDED AND DECREED that per the verdict referenced above, on the claim of retaliation against Defendant City of Kansas City, Missouri, judgment is entered in favor of Plaintiff in the amount of \$296,183.91. This amount includes attorneys' fees and court costs that are assessed against the Defendant City of Kansas City, Missouri.

The hearing set for May 28, 2014 at 1:30 pm is CANCELLED.
