Offenses:
FRAUD / BREACH OF TRUST

On 10/10/2023 at 1700hrs it was brought to the attention of Chief Goodwin, that subject David Watson was claiming a large amount of overtime every week. Chief Goodwin presented the accusation to Mayor Michael Miller and Mayor Pro Tem George Smith and requested consent to investigate this incident. On 10/11/2023 Chief Goodwin met with Angel Jeffcoat the Town Clerk and requested Watson's check stubs dating back to the first of July 2022. Said check stubs revealed 20-26 hours of overtime every week since July of 2022 until 10/11/2023. Chief Goodwin totaled up the overtime and amounts claimed (over 1700hrs and over \$42,000) and presented these findings to Mayor Miller and Mayor Pro Tem Smith. On 10/19/2023 Mayor Miller met with Watson and Watson resigned from his position with the Town of Wagener. Chief Goodwin was advised by Mayor Miller that this investigation is to be turned over to SLED for any further investigation. This concludes Wagener Police Department's investigation into this incident.
